

# TERMS OF USE

## 1. INTRODUCTION

Welcome to EuroT!

These Terms of Service govern your use of our website located at investrix.io operated by EuroT.

Our Privacy Policy also governs your use of our Service and explains how we collect, safeguard and disclose information that results from your use of our web pages.
